**Hiking Equipment Loan Agreement**

Dear Parents,

Fundraising efforts by the VISTA staff and students have resulted in our being able to purchase some necessary equipment for our outdoor education program and hiking trips. It is the desire of the VISTA staff to make available on a loan-type basis the more costly items, thus preventing any financial burden on the families to purchase these items.

All of the equipment purchased by VISTA is of excellent quality and has been designed specifically for the type of use that it will receive. In order to maintain and preserve the equipment for years to come, VISTA is requiring that a parent or guardian sign the enclosed "Hiking Equipment Loan Agreement". The parent or guardian accepts financial responsibility for replacement should any of the items borrowed is lost, stolen, or damaged beyond repair. Your child will be reminded by the staff upon the issue of equipment of your commitment and the expectation by all concerned that they will take care of it.

The items available under this agreement are rain gear and polyester clothing (t-shirts, turtlenecks, long john bottoms, socks, shorts, and fleece pullovers).

**Cotton clothing is "not" permitted on the Fall Overnight.**

Rain gear will be issued to the students within the first few weeks of the start of the school year once a signed agreement is received. **They will have 24 hours to inspect their assigned rain gear to insure it is in good condition and free from damage. After the 24 hour inspection period, any subsequent damage will be the responsibility of the student to whom the rain gear is assigned. We encourage you to assist your child in the inspection.** The rain gear is needed throughout the school year for outdoor education activities and science observations. It will be kept in school at all times, maintained by the student and laundered on a regular basis. Polyester clothing will be issued prior to the Fall Overnight trip. This clothing shall be laundered following the trip and promptly returned.
